



Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, provincial and local governments and federal and provincial health agencies recommend physical distancing and have, in many locations, prohibited the congregation of larger groups of people. The Kawartha Cycling Club (KCC) is following the Ontario Provincial recommendations allowing up to 10 cyclists to ride as a group, provided proper distancing of 2 meters takes place (This recommendation is subject to change). All members acknowledge that they will do their best to maintain this 2-meter spacing as well as possible, but understand the difficulty of doing it throughout the ride and in no way hold other club members responsible.

The KCC has put into place, as well as possible during group rides, preventative measures to help reduce the spread of COVID-19; however, the KCC cannot guarantee that you will not become infected with COVID-19. Further, attending club rides could increase your risk of contracting COVID-19. Club Members, by signing this waiver acknowledge that they have read "KCC's Response to COVID-19" on the KCC website and agree that they will to the best of their ability follow these rules.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participating in a Club ride and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a Club ride may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club Directors, Ride Leaders, Volunteers and other Ride participants.

I voluntarily agree to assume all of the risks and accept sole responsibility for any injury to myself (including, but not limited to personal injury, disability and death). On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the KCC, its directors and other members of the KCC, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Club, its

directors or other members, whether a COVID-19 infection occurs before, during or after participation in any Club ride or event.

By proceeding, I acknowledge that I have read the Assumption of the Risk and Waiver of Liability Relating to Coronavirus/ COVID-19 and understand it, that I have executed this agreement voluntarily, and that this agreement is to be binding upon myself, my heirs, spouse, children, parents, guardians, next of kin, executors, administrators and legal or personal representatives.
